PrimeCredit reserves the right not to grant the cash reward to the Referring Customer if the information on the Referred Customer is invalid or obtained improperly by the Referring Customer. 5. The Referring Customer and the Referred Customer have to complete this form to be eligible for the Program. 6. The cash reward to be granted to the Referring Customer is calculated based on the approved loan amount of the Referred Customer, HK\$100 for every HK\$10,000 of the approved loan amount (capped at HK\$3,000) or any cash reward as announced by PrimeCredit from time to time. 7.
